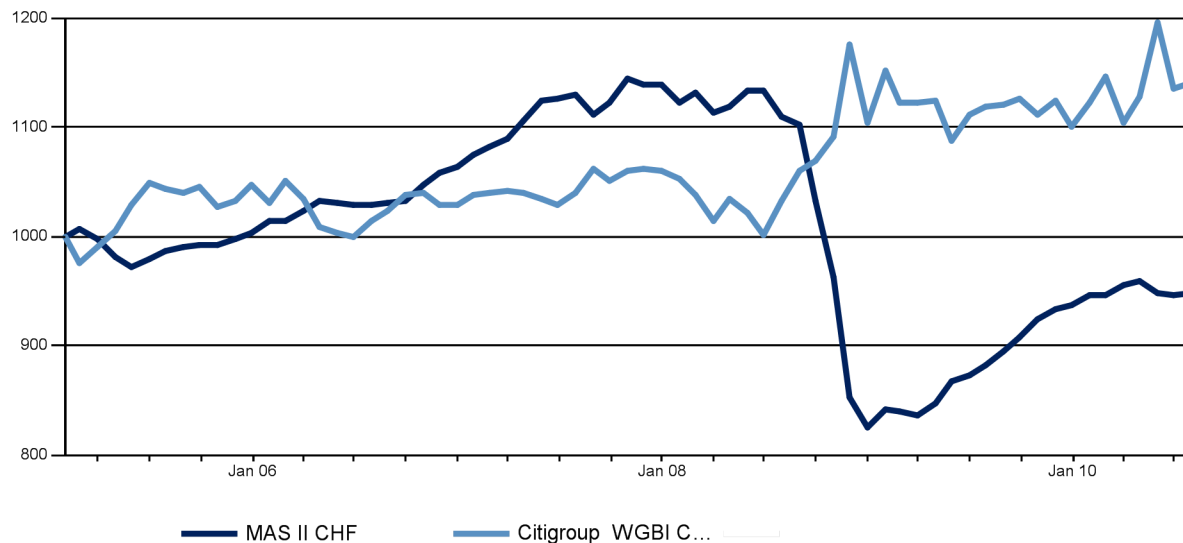

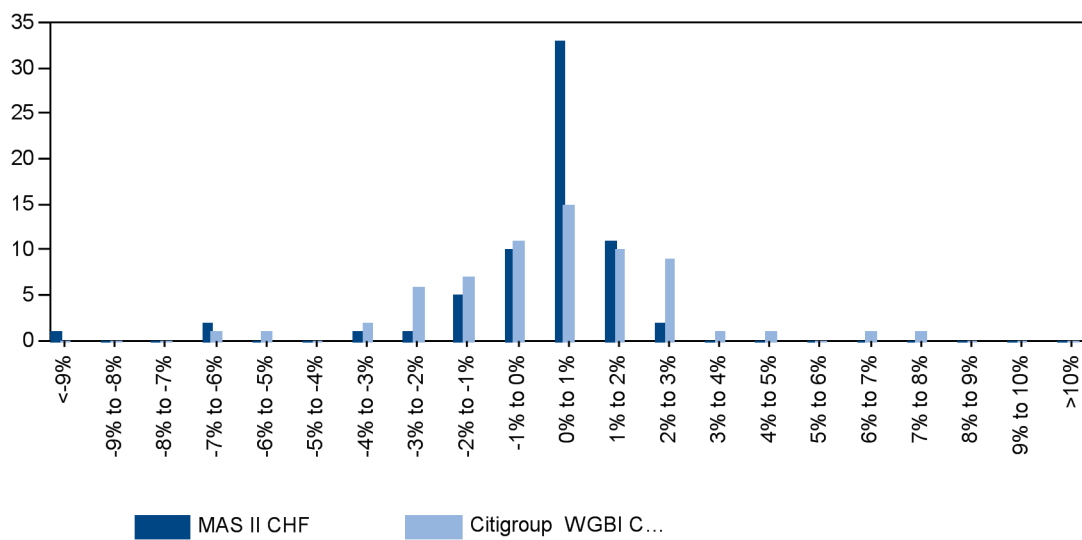

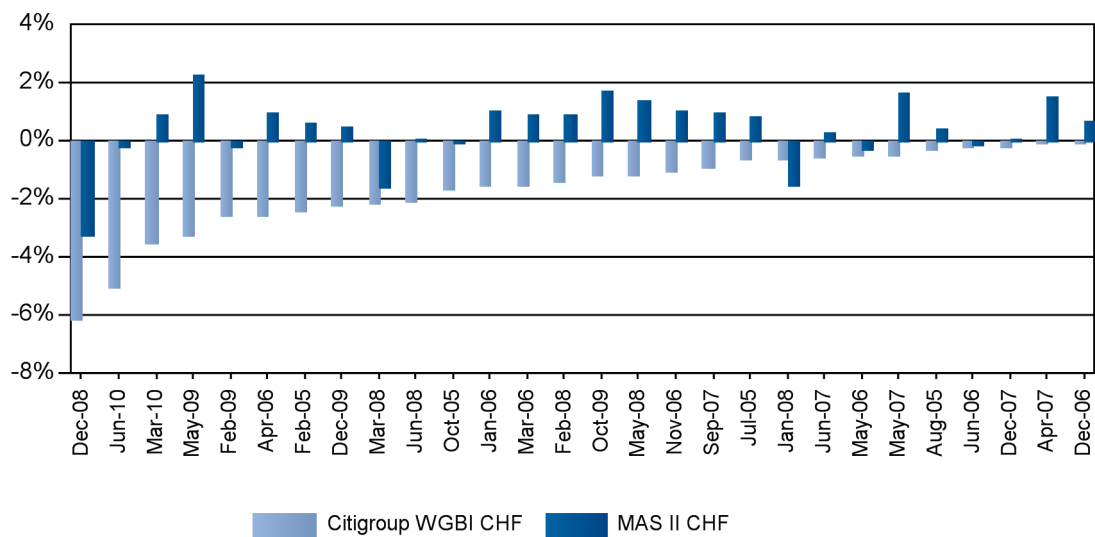
## STRATEGY ALLOCATION AND THREE MONTH ATTRIBUTION ANALYSIS
